

IPS, UK – Free Prize Draw Terms and Conditions (2026)

1. Agreement to Terms

By entering the prize draw, you agree to these terms and conditions.

2. Organiser

The prize draw is being run by IPS, UK. **Eligibility to Enter**

1. The prize draw is open to individuals aged 18 and over who are employed by a Local Authority, Private Operator, or Land Owner.
2. By entering, you confirm that you are eligible to do so and have the authority to select the recipient of the prize donation.
3. A maximum of one entry per individual is permitted.
4. The prize draw is free to enter.

5. How to Enter

1. To enter, you must complete a Charity Prize Draw Card and return it to the IPS, UK Stand (P70) at ParkEx 2026.
2. Entries require participants to provide their details on the Prize Draw Card, which must be handed to an IPS, UK representative on Stand P70 at ParkEx 2026.
3. IPS, UK is not responsible for incomplete or inaccurate contact details provided.

The Prize

1. The prize consists of four charity donations of £100 each, awarded to a charity chosen by the winners.
2. IPS, UK's selection of prize donations does not imply endorsement or affiliation with any specific charities
3. Winners will be drawn at random at intervals during ParkEx.
4. The prize is non-exchangeable, non-transferable, and no cash alternatives will be offered.
5. IPS, UK reserves the right to select an alternative charity if the winner's chosen charity does not meet internal criteria or expectations.
6. IPS, UK's decision regarding any aspect of the prize draw is final and binding, and no correspondence will be entered into.

Winner Announcement

1. Winners will be announced at Stand P70 throughout the ParkEx exhibition. If winners are not present at the stand, IPS will contact them within 48 hours of the event's conclusion.
2. IPS will attempt to contact winners via email up to two times.
3. If a winner does not respond within 14 days of the second email, they forfeit their prize, and IPS reserves the right to select an alternative winner.

Data Protection and Publicity

1. Winners agree to participate in a photo opportunity with an IPS, UK representative at a pre-arranged date after ParkEx. These images may be shared across IPS, UK's social media platforms to announce the winning charities.
 2. IPS will transfer the winning donation amount to the chosen charity's bank account within 21 days of confirming the winners.
